

The database

- The organic seed database was slightly re-designed, especially for vegetable applications
- domestic vegetable seed companies were encouraged to register their organic seed offer in the database
- currently about 130 vegetable varieties are offered in the database
- efforts were placed for improved description of seed mixtures in the database
- no "Annex 1" species are introduced in Austria

Expert groups

- An Expert group was established in 2011
- This "working group for organic seed" is under the responsibility of the Ministry for Health (Codex-commission for Organic farming) and is chaired by AGES
- There are at least two working group meetings per year
- subjects of the working group are:
 - elaboration of species for general derogations
 - harmonisation of procedures for individual derogations
 - discussion and feedback on basis of the derogation reports
 - further developments of the database and procedures
 - other general organic seed issues

Derogations

- Individual derogations are issued by the inspection bodies; the data are transferred once a year to the competent authority
- The derogation report is prepared and concluded by AGES
- The number of general derogations for agricultural species is quite stable
- New: for vegetable seeds general derogations are only established for species without any offer in the database
